## **MINUTES OF BUDBROOKE PARISH COUNCIL MEETING WEDNESDAY 3rd DECEMBER 2014 AT BUDBROOKE VILLAGE HALL**

Present: Councillors Bryan, K.Dutton, M. Dutton, Reid, Robey, Shirley, Simmons, Standbridge, Thomas; Richard Morton

### **1 PUBLIC COMMENTS**

One member of the public was present and involved in the discussions about parking in Hampton Magna.

PC Manjit Sidhu attended to discuss the parking problems on Blandford Way. PC Sidhu advised that police officers have attended on several occasions over recent years but they have been unable to take any action as no offence has been committed; they can only take action if a vehicle is causing an obstruction that completely blocks the road. No accidents have been reported in the last six years. The options for controlling parking were discussed and it was agreed that the clerk would find out how to apply for parking restrictions, for example restricting parking to 30 minutes at certain times of day, and how this is monitored. PC Sidhu agreed that the police would look at ticketing cars parked close to the junction in the dark without lights, but advised that any car in the vicinity parked in such a manner could be ticketed, not just those on Blandford Way. Inconsiderate and dangerous parking near the school continues to be monitored by the police.

The chairman thanked PC Sidhu for coming to talk to the council.

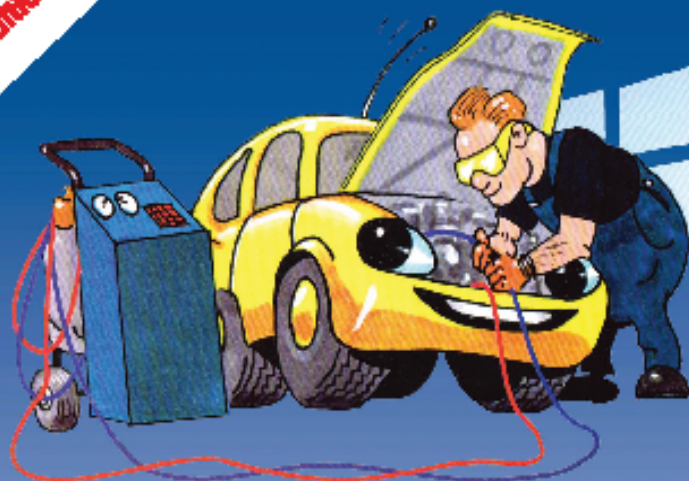

## 7 MATTERS ARISING

### Encroachment onto PC land at Montgomery Avenue

It was agreed that the clerk would ask Legal Services to send another letter asking when the fence will be moved.

### Unregistered Land in Hampton Magna

WALC has no record of an open spaces project being carried out, so are unable to help with this matter. Legal Services have advised that it would be a very difficult and lengthy process to obtain a legal transfer of the land if it had never been transferred from the original developer and the company no longer exists. The land cannot be claimed through adverse possession as it is not being used by the parish council.

It was suggested that the land could be regularised as Village Green. The clerk to investigate this.

## 8 CORRESPONDENCE

## 9 PARISH MAINTENANCE

The clerk to refer the following items to the appropriate departments:

- Uneven pavement outside 8 Slade Hill
- Hampton Road by the allotments – the verge is encroaching on the path & the hedge needs to be cut back
- Old Budbrooke Road between the field and the railway bridge – the hedge needs to be cut back
- Fly tipping on Woodway

Fly tipping on the farm lane in Hampton on the Hill that has not been cleared for several weeks has been reported to WDC. They will not clear the fly-tipping as it is on private land, but will monitor this.



It was noted that resurfacing of the Dorchester Avenue/Chichester lane loop footpaths will not now take place next year due to budget constraints.

Lack of lighting by the war memorial on Blandford Way was discussed. Concerns were noted about safety in this area if youths are congregating there, but it was agreed that this was probably a one-off incident; this will be monitored. The cost of installing a street light would be a minimum of £2,500 (quote from WDC; additional costs would be incurred for work on the highway). It was agreed that a street light would not be installed.

#### 10 MATTERS PERTAINING TO OUTSIDE BODIES (CC / VH / OTHER)

- Community Centre – The bingo session to raise funds for memorial benches will be held on Sunday 7th December.
- The chairman reported that the statue commissioned by the youth group that used to meet at the community centre is now on a plinth at the Saltisford Canal Trust.

are elections for Parish Councils.  
Budbrooke Parish Council is one of these.***

Budbrooke has 9 Councillors supported by a part-time Clerk and Finance Officer. Four years ago, fewer than 9 people stood so all those that were proposed were duly elected without an election being held. If 10 or more people stand then there will be an election.

If you want to stand as a Parish Councillor, you need to start thinking about it now. The following is a brief introduction. Current parish councillors are happy to talk to you about this – contacts on page 2.

There are around 10,000 community, parish and town councils in England and Wales; they are corporate bodies and local authorities. They have a powerful voice to represent local people as they are the part of local government closest to the people. They serve the smallest area and are responsible for the most local of matters. Very importantly, these councils can "precept" - raising a sum collected with the council tax each year to improve facilities and services for local people.

Parish Councils have a number of basic responsibilities in making the lives of local communities more comfortable, many of which are often taken for granted. Essentially these powers fall within three main categories: representing the whole electorate within the parish; delivering services to meet local needs; and striving to improve quality of life in the parish. Individual powers are many and varied.

Parish councils can also comment on planning applications - they are statutory consultees (they have to be consulted if they so wish) and can be represented at public inquiries. Budbrooke PC always comments on planning applications

The council would expect to receive a quote for the work but would pay for a training assessment if necessary.

## 6 PLAYGROUNDS

### Playground report

The report was received prior to the meeting.

### Inspections

RM has arranged to meet with David Connolly from Bishops Tachbrook, who is interested in taking on the playground inspections and litter picking. Mr Connolly will be asked to submit a quote for the work.

The chairman thanked Richard Morton for his help with finding someone to take over the work.

### Extension to the play area at Styles Close

The parish council needs to make plans to fence off the area between the play area and the school field. The clerk to check the lease, for the clauses relating to fencing.

## 7 MATTERS ARISING

### Encroachment onto PC land at Montgomery Avenue

A further letter has been issued by Legal Services to the property owner, requesting a date for the repositioning of the fence. The clerk to take advice from Legal Services regarding the possible sale of the property.

### Unregistered Land in Hampton Magna

Village green and local green space legislation does not apply to this type of land, which is not in regular use by the community. The clerk to contact the resident who brought the matter to the council's attention, stating that the council would have no objections to the resident arranging for the tree to be pruned at the resident's own cost or to take reasonable measures to resolve the problems it is causing, but that the council does not wish to see the tree cut down.

### Station parking on Blandford Way and parking restrictions

The Civil Enforcement department has stated that a request for parking restrictions can be added to the list for consideration by WCC in November 2015. The clerk to confirm that the council would like this to be done and to ask what further information is required and the details of the restriction, including which stretches of road it will apply to. Tracking information for that junction, on both Blandford Way and Field Barn Road, would be required to ensure that any restriction covered the turning area for buses.

# Celebration



Some years ago a group of young people who attended a youth group at Budbrooke Community Centre designed a sculpture. Funding was sought and with the help of the leaders, Paul Margetts created it.

At one time the sculpture was going to be sited at the Community Centre but this never happened, and the sculpture lay warehoused and unseen. Mike Dutton, Chairman of Budbrooke Parish Council, negotiated with the few remaining group leaders and it was agreed that the sculpture should at last see the light of day. On 29<sup>th</sup> November 2014 the newly erected sculpture called Celebration was formally opened by Chris White MP, Nigel Hamilton and Mike Dutton at Saltisford Canal basin.



“Celebration” is located near the Warwick end of the site. There is a gate by the railway bridge and members of the public are welcome to visit it.

“I would encourage anyone who used to be involved with the youth group, indeed anyone from Hampton Magna, to come and see it, and take in the peacefulness of the Saltisford. All we need now is for an additional plaque properly attributing its design to the young people who created such a work of art,” said Mike.

## **11 PLANNING MATTERS**

**Feedback from WALC December meeting attended by Gary Fisher, Development Manager, WDC Planning**

Parish councils can now submit statements in support of planning applications, as highlighted during discussions about the community centre extension. A planning infringement is only illegal once the enforcement officer has made a judgement to this effect.

### **Planning applications:**

- W/14/1533 – 9 Hatton Terrace, Birmingham Road: Erection of a two storey front extension

Drawings to be resubmitted. It was agreed not to consider this application until the new drawings had been received.

### **Planning decisions**

- W/14/1684- Hampton View, Henley Road, Hampton On The Hill: Retention of the existing annex and proposed erection of single storey link building between existing cottage and existing annex (resubmission of W/14/1438).  
Withdrawn

### **Possible enforcement issue**

The clerk to make enquiries about how conditions on planning applications are affected when circumstances change, in particular if an application is granted in connection with a business run from a property but the business is no longer operating.

### **Neighbourhood Plan Update**

The neighbourhood plan area has been designated. The council can now go ahead and apply for money for the plan via Locality, on behalf of the government, and the district council. Money has to be applied for this month and committed or allocated this month. It was resolved to formally set up a neighbourhood plan committee, from the existing neighbourhood plan group, which will manage the process and apply for the relevant grants on behalf of the parish council.

It was noted that the environment agency has now published guidelines for neighbourhood planning.

### **Local Plan**

The plan will go to the council (WDC) for approval on 28<sup>th</sup> January 2015. It is expected to be challenged by developers for not including enough new housing.

The council resolved to set the precept at £22,040, and accept the proposed allocations to reserves as set out in the accounts circulated prior to the meeting. The accounts were signed off by the Chairman.
