Outline Planning Application for 147 houses on land off Daly Avenue **REFUSED**

This application has been REFUSED by Warwick District Council Planning Officers.

The above link gives details of the reasons, but the four reasons in brief are:

- The area is too densely developed and uses land outside the allocated area for open space and drainage purposes.
- There is only one access via Woodway Avenue serving the whole of the new development and Daly Avenue and cul de sacs off. This is more than the 150 dwellings considered safe for emergency vehicles etc.
- The application does not include the necessary bat activity surveys to allow a full ecological assessment to be made.
- No allowances have been made for the provision of increased educational, medical, library, sports facilities etc.

This is excellent news. We await further developments.

at <u>www.noroguetradershere.com/</u> or by Freephone 0800 233 5000 and use the scheme free of charge. They just need to register their basic details, confirm the type of trader and the work they require.

- 1. The customer will then receive a profile of up to 3 scheme members, (depending on the size of the job), who meet their requirements.
- 2. The consumer contacts the traders to get quotes and then makes a decision, with no obligation to proceed.
- 3. A written quote/contract is drawn up by the chosen trader and a start date agreed.
- 4. NRTH monitor the contract, to make sure the quotes are clear, complete, fair and accurate.
- 5. When the work is completed, NRTH then contact the consumer to check that they are happy with the result. If there are problems they will intervene to find a solution, sometimes in consultation with a Trading Standards Officer.

Registered Traders

NRTH and Warwickshire Trading Standards try to be very thorough with their selection process and are very careful with choosing whom they allow onto the scheme. If you know of a local business that specialise in home improvements and maintenance, they are welcome to apply, but they must pass all of the many stringent tests, be fully insured and agree to be closely monitored.




